

PHOTOGRAPHY CONTEST

Diario dalle residenze "Raccontare il luogo"

Purpose

A university residence is a building, or a set of structures, intended to welcome and house students, ensuring spaces for single, common or social use, oriented towards coexistence, respect and solidarity.

Reception in university residences ensures equal treatment for students, without distinctions based on geographical origin, language, culture, gender, religious faith, political opinions, territorial location of services; the criteria for assigning accommodation, the forms of participation and the management of common spaces favor the integration of differences.

The definition of a place cannot be represented only by a description; the gaze of those who experience it and identify it as such is also necessary.

The Company for the right to university education of the Campania Region chooses to speak and make students speak through photography, a highly participatory and universal language, to create a story of their places.

The Company promotes a photographic contest as a simple and current tool to involve the student audience and give a say on the meaning of their living.

Participants

Participation is open to anyone aged 18 or over and who is a student at one of the universities in the Campania region.

Participation is free. The photograph may not be unpublished, it may have already been published on the web and/or on social media, it may have participated in other competitions, but it must not have already been awarded.

Theme

Each author can participate by presenting a single photograph, which must represent the theme "Diary from the residences. Telling the story of the place". The shots will be able to capture both moments of daily life inside the residences and architectural and structural aspects of the residences themselves.

Photographs and methods of participation

Only photographs in digital format can participate in the competition. The photograph may be in black and white or in colour, sent exclusively as a .jpg file, max 1 per participant.

Photographs depicting people who are recognizable in any way must be accompanied by the release attached to the notice.

To participate in the competition it is necessary to fill in the online form with your data, upload the nominated photograph and grant the necessary authorizations for data processing.

Under penalty of exclusion, photographs with logo, signature, watermark and recognizable signs of any kind will not be accepted. Photomontages and photos generated via AI (Artificial Intelligence) will not be allowed. Appearances of products or services that can be traced back to the practice of product placement will not be permitted. Content of a violent, discriminatory, defamatory, obscene, racist or sexual nature will not be permitted. Photo collages are permitted as long as they have a narrative justification in the representation of the theme.

Selection

The photographs received will be selected by a commission made up of communication experts and technical figures from the artistic and cultural sector.

The Commission will be appointed with a specific provision, following the deadline for submitting the photographs.

Awards ceremony

The photos sent will be examined by the Commission, which will identify the best works with a concise justification.

The following prizes will be awarded to the winning works of the competition:

The results of the Commission's work will be published on the Company's institutional website.

Authorization

Each author declares to own all rights to the photograph sent.

Each author retains ownership of the work sent, but transfers the rights of unlimited use of the image and its possible processing to the Company to create exhibitions, photographic collections, publications as well as for any type of institutional use, communicative, illustrative and informative.

Terms

The deadline for participation is set within 30 days from the publication of the notice on the Company website. The material presented will not be returned.

Participation in the competition entails full and unconditional acceptance of these regulations.

Data processing

The participating person agrees to have read the information and to provide their express consent in writing, pursuant to EU Regulation 2016/679 and following, for the communication and dissemination of the personal data provided and collected (including photographs), for the purposes indicated above, by signing the participation application.
