

The following documents are required by the CAF to obtain the ISEEU Parificato, the document to evaluate the financial situation of foreign students and Italian students resident abroad in the academic year 2024/2025

## Personal information of the student and his family

- 1. Identity Document of the student
- 2. Fiscal code of the student (released by Italian Agenzia delle Entrate)
- 3. documents certifying the actual family composition

#### Documents about family income

- 4. Income received by each member of the household for the year 2022. If no income has been eraned in 2022 by the family, it is necessary to provide a certificate attesting the absence.
- 5. Any other income received from the Public Administration, for assistance, social security or indemnity.
- 6. Certification about scholaship received during the year 2022

### Documents about family assests

- 7. Documents certifying real estates that the family holds at the date of 31/12/2022 (houses, lands, etc.). If no real estates were owned by the family, it is necessary to provide a certificate attesting the absence
- 8. Documents certifying movable assets of the family household at 31/12/2022 (balance of bank and/or deposit accounts, account balance of shares, dividends, shareholdings, capitalization policies any other type of financial investment)

All documents must be produced in English language or in original language with traduction in italian by diplomatic authorities in your country:

- A. Exemption from legalization, for countries signatory to specific international agreements
- B. Exemption of legalization, but obligation of apostille stamp, for countries that have ratified the 1961 Hague Convention
- C. In all other cases, obligation of legalization through the Italian Embassy or Consulate in the country of origin

#### NOTE LETTER C:

- A. For foreign students from particularly poor countries referred to in Ministerial Decree 440 of 13/02/2024, it is not necessary to write ISEE parificato if the student is in possession of a certification from the Italian Representation in the country of origin which certifies that the student does not he belongs to a notoriously high-income family with a high social standing.
- B. For students with stateless or political refugee status, ISEE parificato does not need to be drawn up but ISEE certification for subsidized services for the right to study, referring to the registered family nucleus in Italy.
